Summary Statement:

Background:

City Council has previously approved the \$2,000,000 Transportation Improvement Board (TIB) Grant for the SR 503/Scott Avenue Intersection Project. A new fund is needed to help track the revenues and expenses for this project.

In 2013 the City is working on purchasing right-of-way and hiring a consultant to complete the design of the project. In 2014 design and permitting for the project will be completed. Construction is slated for 2015.

In 2013 the City will transfer \$20,000 from the Street Fund 104 to help seed the fund. Additional street funds will be transferred in 2014 and 2015 to used for cash flow and for the grant match for the project.

This Ordinance is needed to create this fund.

WHEREAS, the City finds that the project can be more easily tracked by providing for a separate fund; and

WHEREAS, the City received a \$2,000,000 Transportation Improvement Board (TIB) grant to complete the design and reconstruction of a new intersection at SR 503 and Scott Avenue; and

WHEREAS, the City will be receiving a \$125,000 temporary interfund loan as seed money for the project; and

WHEREAS, the City will transfer \$20,000 from Fund 104 to Fund 325 to pay for the City's 10% match required for the property purchase; and

WHEREAS, in 2014 and 2015 the City will transfer sufficient funds from Fund 104 to Fund 325 for the necessary match needed for the TIB Grant; and

WHEREAS, by this ordinance the City seeks to create a fund number within the 2013 budget and acknowledge projected revenues for appropriation and expenditures during the budget year.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WOODLAND DOES ORDAIN AS FOLLOWS:

Section 1. Creation of Fund. That the 2013 budget of the City of Woodland is hereby amended by the establishment of the following funds:

- A. Fund No. 325 – TIB SR 503/Scott Avenue Intersection project

Section 2. This ordinance shall become effective five (5) days after publication as provided by law.
