Officer Bolo's program is sustained through grants and individual donations from the community.



The Woodland Bottoms & Code Enforcement Community Development

<u>REMINDER!</u> We have been working with Cowlitz County on developing a Memorandum of Agreement (MOA) regarding growth. We have finally agreed to a document that spells out how a master plan of the Woodland Bottoms will occur. Before everyone takes that to mean the City of Woodland is annexing the Woodland Bottoms, that is not what the MOA represents. The MOA is a document that states the city and Cowlitz County will work together developing a plan for future development, if it occurs. As mentioned in other newsletters, the city is responsible for managing growth and the impacts that come with growth (example is Exit 21). The MOA is also an opportunity for other organizations to be part of the conversation and how to manage growth effectively. *(The Port, School District, Diking District, Planning Commissions, Emergency Services, and the list goes on!)* There will also be public outreach and participation. *The MOA will be on the next agenda, June 19th, with a Public Hearing attached so you can testify on the document.* A copy can be found here: moa for woodland bottoms joint planning1192356.9-1.pdf

Code enforcement seemed to be a hot topic after the last newsletter (June 12, 2023) regarding the retail marijuana store that is open along State Route 503, inside the city limits. City Council has chosen **NOT** to allow the sale of retail marijuana on a number of occasions, all the way back to 2014. It appears there is some confusion on state licensing versus city licensing. In this case, the State of Washington has licensed the facility to operate in the State. However, the business is still required to follow all rules, codes, and regulations within the jurisdiction the business operates within. A state license is not a blanket "GO FOR IT" license. Any business still needs to follow the local jurisdiction regulations. <u>This business is currently NOT licensed to operate inside the city limits.</u>

As mentioned in my last newsletter, the City of Woodland's code enforcement office is complaint driven. The above code enforcement on the retail marijuana store began after receiving two code enforcement complaints. My office and city council **DID NOT** direct action against this retailer, your neighbors asked code enforcement be taken (*CE-0015 & CE-0016*). All Hands On Deck!

Public Works

Similar to the team at the Woodland Police Department, it was all-hands-on-deck for the annual Planters Days celebration. Once again, this team of dedicated employees went above and beyond! The city was well prepared and looked its best once again. I received many compliments from residents and visitors on how awesome the city looked. Streets swept, flower beds weeded and spruced-up, and flower baskets and banners placed just right! THANK YOU!

Public Works is wrapping up the Asbestos water line replacement on W. Scott Avenue, which will lead to the long awaited and planned full depth reclamation of W. Scott Avenue and Guild Road. This will include pedestrian sidewalks and ADA ramps. Please anticipate delays on W. Scott Avenue during construction of this road and pedestrian access. Check the city website for progress. The estimated cost of the project is \$3.2M and we are required to match only 8%, which is around \$250K! This is a great way to stretch your tax dollars. The projects are funded with American Rescue Plan Act *(ARPA)* and state grant dollars.

Public Works is hosting <u>Hot Summer Nights and Movies in the Park</u> again this year. The first night is June 23rd, this Friday. The live band is 24-7 and the movie is *Minions Rise of Gru*. In addition, *Downtown Woodland Revitalization (DWR)* will join in on the fun and host a beer garden, with ticket pre-sales going on now at a reduced cost. Pick up your tickets at Public Works. *Veterans of Foreign Wars (VFW)* will be hosting a hot dog feast during these events.



Volunteers Needed Recreational Facilities

Public Works is seeking volunteers to help clean-up a 10-acre parcel along the Lewis River. The parcel of land is located between Insel and Gun Club Roads and was a donation to the city years ago. The 10-acres is intended to allow continued public access to the river, regardless of development around the parcel. The parcel is overrun with the invasive species "scotch broom". Because the parcel is within the shoreline, it must be removed by hand and large equipment cannot be used. We want to make sure the area is easily accessible to the public and we are seeking your help to make this happen! If you would like to sign-up to help, or have an organization that needs service hours, please contact Public Works and put your name on the list (360-225-7999). You will be contacted when a date is set for clean-up.

Public Works is asking for your help! They're asking you take a moment *(less than 3 minutes)* and complete the <u>ADA Public Out Reach Survey | Woodland Washington</u>. This survey will help with addressing ADA needs in the city. As a city, we want to make sure everyone who lives, works, and visits Woodland has a positive, accessible experience. Survey will close July 19, 2023.

Public Works needs volunteers for *Make a Difference Day*. This event will be held on October 28th this year. Please contact Public Works at 360-225-7999 and register your team to volunteer. This is a great event for Boy and Girl Scout Troops, Churches, families, and clubs that want to make a difference in our community. We work from about 8-Noon on that day throughout the city.

City Hall

The new Woodland Civic Center has gone out to bid. What does that mean? Well, city council approved to spend grant dollars received for the design of a new community facility at the corner of Lakeshore Drive and Goerig Street. We have requested a bid for the actual construction of the facility. Once the bids are received, we will have a better understanding of what it will cost to build and a financial plan can be put together and presented to city council. Currently, we have been awarded/received just over \$200K in funding towards this project. The handouts will soon make their way to the website for electronic access. Many information boards were also available to update those that stopped in on happenings around the city.
