

ORDINANCE NO. 1150

AN ORDINANCE RELATING TO FINANCE AND AUTHORIZING AN INTERFUND LOAN FROM FUND 302 – CAPITAL RESERVE: UTILITIES TO FUND 227 – CERB #T93-028 SEWER LOAN AND APPROVING AN ORDINANCE SUMMARY FOR PUBLICATION AS MORE PARTICULARLY SET FORTH HEREIN.

WHEREAS, circumstances require a short-term interfund loan from Fund 302 – Capital Reserve: Utilities to 227 – CERB #T93-028 Sewer Loan. Anticipated receipts have not been received; and

WHEREAS, Anticipated receipts are still forthcoming and expected after the debt service payment was due on January 1st; and

WHEREAS, an Assessment against the LID Property owners is being prepared pursuant to the 1994 Pre-Annexation Agreement and receipts from this are also forthcoming. Therefore, an interfund loan is required to pay the outstanding bills.

NOW, THEREFORE, THE CITY COUNCIL OF THE CITY OF WOODLAND, STATE OF WASHINGTON DOES ORDAIN AS FOLLOWS:

Section 1. That the City Council of the City of Woodland does hereby authorize and approve an interfund loan in the amount of Twenty one thousand six hundred and eighty five dollars (\$21,685) from Fund 302 – Capital Reserve: Utilities to 227 – CERB Sewer Loan for a twelve (12) month period. Said loan shall bear interest at the rate of 0.42% per annum as shown on Exhibit “A” and may be paid at maturity or at such earlier date as the City’s clerk-treasurer may deem appropriate.

Section 2. This Ordinance shall become effective five (5) days after passage, approval and publication as provided by law.




