

ORDINANCE NO. 1215

AN ORDINANCE AMENDING WOODLAND MUNICIPAL CODE 5.04.090 – BUSINESS LICENSE ISSUANCE - EXPANDING THE LEGAL COMPLIANCE TO INCLUDE ALL LOCAL, STATE, AND FEDERAL LAWS

WHEREAS, pursuant to RCW 35A.11.020 and the Constitution of the State of Washington, Article 11, Section 11, cities have the power to enact regulations in the interest of the health, safety, and welfare of their residents;

WHEREAS, all procedural requirements of the Woodland Municipal Code (WMC) for this amendment have been met;

NOW THEREFORE, be it hereby ordained by the City Council of the City of Woodland as follows:

SECTION 1. WMC 5.04.090

Old Section: The following section of the Woodland Municipal Code (WMC) is repealed:

5.04.090 – Compliance with other applicable ordinances.

Issuance of a business license shall not relieve the applicant from the need to comply with all other applicable city ordinances.

New Section: The following language hereby replaces the above referenced language:

5.04.090 – Compliance with other applicable laws.

A business license will not be issued for any activity that is known to violate local and/or state and/or federal law. Issuance of a business license shall not relieve the applicant from the need to comply with all other applicable city ordinances.

SECTION 2. SUMMARY

A summary of this Ordinance shall be published as required by law.


SECTION 3. EFFECTIVE DATE


