

**CITY OF WOODLAND**

**ORDINANCE NO. 1250**

**AN ORDINANCE ADJUSTING RATES FOR GARBAGE AND REFUSE COLLECTION AND DISPOSAL PER FRANCHISE CONTRACT**

The City Council of the City of Woodland finds as follows:

**WHEREAS**, Ordinance No. 898 provides that rates charges and fee relating to the collection of garbage and recycle material will be established by resolution of the City Council; and

**WHEREAS**, on August 15, 2005, the City of Woodland entered into a franchise contract for Garbage and Refuse Collection and Disposal with Waste Control Equipment, Inc. which addresses rates for the contract period; and

**WHEREAS**, Waste Control notified the City of Woodland that they were requesting a CPI rate adjustment pursuant to the current contract.

**NOW, THEREFORE, BE IT ORDAINED** by the City Council of the City of Woodland as follows:

The rates, charges and fees applicable to the City's solid waste program shall be and are hereby fixed and imposed, effective October 16, 2012, and the Woodland Municipal Code shall be amended as follows:

**1. Current Law – Woodland**

The current law amended by this ordinance as provided in Ordinance No. 898 and Resolution No. 616 and Ordinances 913 and 611.

**2. Woodland Municipal Code**

**1. RATES – RESIDENTIAL**

For the collection and disposal of garbage/refuse at the curbside:

Monthly rates - Weekly Service

Each 60 gallon container	\$10.96 per month
Each 90 gallon container	\$18.98 per month

For the collection and processing of recycle materials:

Monthly rates - Weekly service

60 gallon container	\$ 4.27 per month
---------------------	-------------------

The charge of additional extra units or over-weight units on a regular scheduled pickup day is \$2.94 each.

Container weights cannot exceed 200 lbs. (container and contents). Containers that exceed 200 lbs. will be charged \$2.94 for each 50 lbs. increment over 200 lbs.

2. RATES - SMALL COMMERCIAL

For the collection and disposal of garbage/refuse at the curbside:

Monthly rates - Weekly service \*

Each 60 gallon container \$10.96 per month  
 Each 90 gallon container \$18.98 per month

\* For service more frequent than weekly, multiply the rate set out in this subsection by the number of times per week service is rendered.

The charge of additional extra units or over-weight units on a regular scheduled pickup day is \$2.94 each.

Container weights cannot exceed 200 lbs. (container and contents). Containers that exceed 200 lbs. will be charged \$2.94 for each 50 lbs. increment over 200 lbs.

3. RATES – COMMERCIAL

For the collection and disposal of garbage/refuse:

Monthly rates - Weekly Service \*

Each 300 gallon container \$71.89 per month  
 Overweight units per 100 lbs over 450 total lbs \$5.35

\* For service more frequent than weekly, multiply the rate set out in this subsection by the number of times per week service is rendered.

Additional extra units \$2.94

Front load rates - Non-Compacted Material

NOTE: All front-load containers that exceed the weight limits below will be charged \$10.70 per yard fee per pick-up.

- 2-YD front load container weight cannot exceed 600 lbs of contents.
- 3-YD front load container weight cannot exceed 900 lbs of contents.
- 4-YD front load container weight cannot exceed 1200 lbs of contents.
- 5-YD front load container weight cannot exceed 1500 lbs of contents.
- 6-YD front load container weight cannot exceed 1800 lbs of contents.

COMMERCIAL RECYCLING:

For the collection and processing of recycle materials:

Monthly rates - Weekly service \*

60 gallon container	\$ 8.55 per month
90 gallon container	\$12.08 per month
300 gallon container	\$47.57 per month

The charge of additional extra units or over-weight units on a regular scheduled pickup day is \$2.67 each.

Container weights cannot exceed 200 lbs. (container and contents). Containers that exceed 200 lbs. will be charged \$2.67 for each 50 lbs. increment, or fraction of, over 200 lbs.

\* For service more frequent than weekly, multiply the rate set out in this subsection by the number of times per week service is rendered.

4. NON-CURB ROLL-OUT SERVICE (includes Residential & Commercial for both garbage/ refuse and recycling rates)

For the garbage/refuse and recycle residents and commercial places of businesses that find it necessary for the CONTRACTOR, to move their container to a placement point, for the collection of, the following rates will apply:

Monthly rates - Weekly Service \* #

60-90 gallon container	\$ 5.35 per month
300 gallon container	\$13.36 per month

\* For service more frequent than weekly, multiply the rate set out in this subsection by the number of times per week service is rendered.

# For bi-weekly service, the rate per month would be one half the monthly rate as set out in this subsection.

Roll Out Charges – Front load Containers

**Charges for containers.** The company will assess rollout charges where, due to circumstances outside the control of the driver, the driver is required to move a container more than five feet, but less than twenty-five feet, in order to reach the truck. The charge for this rollout service is:

\$3.15 per container, per pickup each way (pulled out and returned.)

5. RATES - DROP BOX - NONCOMPACTED MATERIAL

For the collection and disposal of garbage or refuse from commercial and/or industrial sources, the following rates and charges will apply:

6. RATES - STATIONARY PACKER - COMPACTED MATERIAL

7. RATES - LOOSE AND BULKY MATERIAL

For the removal of loose and bulky garbage or refuse, the following rates will apply:

<u>Bulky Materials</u>	<u>Loose Materials</u>
\$15.77 per yard	\$25.12 per yard

8. EXTRA CHARGE - RETURN TRIP

If it is necessary that the collector makes a return trip to pick up garbage or refuse because of a failure of the occupant to place the garbage cans in the designated area, a six dollar ninety five cent (\$6.95) charge will be made in addition to other regular rates established in this exhibit.

9. RATES - RESIDENTIAL - SENIOR CITIZENS' DISCOUNT

A discount, not to exceed two dollars sixty nine cents (\$2.69) per month in residential rates, may be allowed to a head of household over the age of sixty-two years who applies and qualifies for such discount pursuant to Section 13.08.140 of the Woodland Municipal Code.

**3. Severability**

If any section, sentence, clause or phrase of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or constitutionality shall not affect the validity or constitutionality of any other section, sentence, clause or phrase of this ordinance.

**4. Effective Date**

This ordinance shall become effective five (5) days after its publication in the media or paper of record as required by law.

**5. Publishing**


A Summary of this Ordinance shall be published.

This ordinance shall be in full force and effect beginning October 16, 2012.




