

RESOLUTION NO. 592

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF WOODLAND, WASHINGTON, PURSUANT TO SECTION 209 OF REFERENDUM NO. 47 OF THE STATE OF WASHINGTON, AUTHORIZING AN INCREASE IN THE REGULAR PROPERTY TAX LEVY, IN ADDITION TO ANY AMOUNT RESULTING FROM NEW CONSTRUCTION, IMPROVEMENTS AND ANY INCREASE IN THE VALUE OF STATE-ASSESSED PROPERTY, FROM THE AMOUNT THAT WAS LEVIED IN 2010 TO AN AMOUNT WHICH IS 2.31086% THEREOF.

WHEREAS, the City Council of the City of Woodland, State of Washington, has met and considered its budget for the calendar year 2011; and


WHEREAS, the City Council of the City of Woodland, after hearing and after duly considering all relevant evidence and testimony presented, determined that the City of Woodland requires a regular levy in the amount of **\$1,153,114.60**, which includes an increase in property tax revenue from the previous year, and amounts resulting from the addition of new construction and improvements to property and any increase in the value of state-assessed property, and amounts authorized by law as a result of any annexations that have occurred and refunds made in order to discharge the expected expenses and obligations of the City of Woodland and in its best interest;

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Woodland as follows:

That an increase in the regular property tax levy, is hereby authorized for the 2011 levy in the amount of \$25,276.00, which is a percentage increase of 2.31086% from the previous year.




