11. Surety bond - In lieu of investigation/waiting period. If any applicant for a license shall desire issuance of a license by the Clerk-Treasurer's office immediately upon application, he/she may deposit at the time of making application a cash or surety bond to be approved by the Clerk-Treasurer in the sum of \$1,000 (WMC 5.16.100).
12. A license shall be required of **all individual peddlers** where more than one peddler is working for the same company.
13. Such license shall be carried at all times by each solicitor for whom license is issued, when soliciting or canvassing in the City, and shall be exhibited by any such solicitor wherever he/she shall be requested to do so by any police officer or any person solicited.
14. All orders taken by licensed solicitors shall be in writing and in duplicate, stating the name as it appears on the license, and address of both the solicitor and his employer, the terms thereof, and the amount paid in advance, and one (1) copy shall be given to the purchaser.
15. Violation of this Ordinance shall be considered as a misdemeanor and any person convicted of a violation shall be punished as provided in Woodland Municipal Code 1.12.010.
