I. DESCRIPTION OF PROPOSAL

The city is considering amending the 90-consecutive day occupancy standard for recreational vehicles in RV parks. The council is considering year-round occupancy under some circumstances.

II. ENVIRONMENTAL REVIEW

The City of Woodland has reviewed the proposed code amendment for probable adverse environmental impacts and expects to issue a determination of non-significance (DNS) for this project.
